The meeting of the National Center For Research Resources Comparative Medicine Review Committee was convened on June 10, 2003, at 8:00 a.m., at the Bethesda Marriott Suites, Bethesda, MD. John K. 1 Midcareer Investigator Award in Biomedical and Behavioral Research application requesting \$480,091 in support.

8 Research Project applications requesting \$13,501,997 in support.

2 Research Scientist Development Award - Research & Training applications requesting \$1,218,109 in support.

9 Resource-Related Research Projects applications requesting \$23,208,221 in support.
